

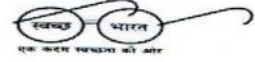

INSTRUCTIONS TO THE BIDDER AND OTHER TERMS AND CONDITIONS

A) EARNEST MONEY AND THE VALIDITY OF THE TENDER

1. Each tender shall be accompanied by the requisite earnest money in the form of Bank Guarantee/FDR/CDR/DD in favor of Senior Finance Officer, Nagar Nigam Dehradun.
2. Without earnest money tender is liable to be disqualified
3. Earnest money shall be returned after the supply of the equipment at the store at NAGAR NIGAM DEHRADUN or may be adjusted in the security deposit if desired by the bidder.
4. Validity of the offer must be 06 months from the date of submission of tender.

B) CASTING AND OPENING OF THE TENDER

1. The tender must be newly written, preferably typed. Every page of the tender document should be signed with seal. The rate must be quoted in words also.
2. NAGAR NIGAM DEHRADUN holds the right to reject any or all the tenders or accept any tender after analyzing technical bid and financial bid in total or in part of work may be decided among various tenders without assigning any reason.
3. NAGAR NIGAM DEHRADUN has right to change the time of opening of technical and financial bid at anytime.
4. Tender must contain the name, address, place of business, land and mobile nos., email, website. The representative must bring the authorization letter from the tenderer, having representative's attested signatures.
5. Any approach / undue pressure by any firm shall render the tender liable to be rejected.
6. Any tender if deviates from the given terms and conditions and technical specifications specified in the tender shall liable to be rejected. But better specifications shall be welcomed, but with the prior approval of authorities/Nagar Nigam Dehradun.

7. On acceptance of the tender, the tenderer will be required to execute an agreement which will be treated as contract for the tendered work on non judicial stamp papers of required value, as per **G.O's** provisions.
8. If tenderer fails to sign the agreement within the stipulated period of 1 week from the date of the confirmation of the lowest bidder its earnest money shall be forfeited by the department.
9. The tendering firm/ company should be registered under the relevant statues by the relevant competent authority. The firm must attach copy of the registration certificates.
10. The tender price will be inclusive of all taxes and duties, i.e., central/ state and local taxes, GST etc. **F.O.R Dehradun**
11. The Bidders should have a turnover of minimum Rs.1.5 cr. Per year for last three Financial Years.
12. Bidder must be manufacturer and should have supplied at least of 100 Steel Bins of 1.1 cum capacity in the last 3 years to any Govt. department/ local bodies

Payment Condition

13. After Successful supply and Installation of the equipment payment may be released.
14. At the time of payment as per the standard practice of the government department a Security Deposit of 1,00,000 of contract price in shape of **Bank Guarantee/FDR** pledged in the name of Nagar Nigam Dehradun shall be submitted. This may be released after 06 months on proper functioning of the equipment.

MS Sheet Garbage Containers for waste collection shall be provided with 4 Castor Wheels with Blocking System. The Garbage Collection Containers shall be of **1100 Ltrs** Volume. These shall be closed type hygienic Containers. The Container construction shall be of Pressed Steel Sections for ensuring adequate structural strength required for handling with the Compactor Bin Lifter (compatible with Nagar Nigam Dehradun compactor). Also, Container shall be designed with facility to be easily handled by two Bin Handlers.
